# **Terms & Conditions**

**RESERVATIONS:** Accepted up to 3 business days prior to US departure for hotels and most services.

**CONFIRMATION:** Normally provided within 24-48 hours. If a requested hotel or service is unavailable, a suitable alternative will be offered. (not applies for special requests or group reservations)

**RATES:** Determined and subject to availability at the time of booking. Surcharges may apply for certain holiday, trade fair, and/or weekend periods. Subject to change without notice due to currency fluctuation, changes in government taxes and/or contract amendments. Rates are guaranteed upon acceptance of full payment. All rates are in US dollars.

**HOTEL ARRIVAL & DEPARTURE:** Varies by property, but cannot be guaranteed prior to 3pm. Departure is typically required by 11am.

**AIR CONDITIONING: Russian American Consulting** cannot accept responsibility for actual air conditioning standards or availability, which may vary greatly between countries and properties.
